The bids will be opened in the presence of Bidders' representatives who choose to attend at 13.00, 2079/12/10 (2023/03/24) at the office of Sangurigadhi Rural Municipality, Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amount as stated above deposited at Dharauti account No. 21101017500037 on behalf of Sangurigadhi Rural Municipality at Nabil Bank Ltd ,Sangurigadhi Branch or bid bond authorized from a recognized "A" class commercial bank or Financial institution eligible to issue bank guarantee as per prevailing law of Nepal. A scanned copy of the bid security in pdf format, amounting to a minimum of 19,000.00 which shall be valid for 30 days beyond the validity period of the bid.
